### TERMS AND CONDITIONS

Works of any durable medium will be accepted—wall based works to be no larger than two square metres in area excluding frame and 3D works no larger than one metre wide, one metre deep and two metres high, these works must fit through a doorway of 1.5 metres wide by two metres high.

Entries must be the work of the artist named, and all works completed after January, 2011.

All works must be for sale and a commission of 20% will be retained from all sales.

The Committee reserves the right to use the images of the selected artworks for catalogue and advertising purposes.

Entries are limited to three per person and each work must be accompanied by an entry fee of \$22.00 (inc gst) to be eligible.

## JUDGING

The judging will be carried out by an independent person, engaged to fulfil this position. All work will be considered during the pre-judging round by the Judge.

Those works selected from the digital images will form the exhibition for final judging.

All artists will be advised if their entry is accepted. Delivery and return details will be given at that time.

**Date of delivery to the Civic Hall will be:  
Friday December 16th by 4.00pm.**

The decisions of the judge will be final, and no explanation will be entered into.

### PRESENTATION OF WORK

- All wall based works should be made ready for hanging, with flat D rings of at least 15mm wide, with suitable hanging wire on the back of the work. 3D work should be able to be moved easily, and be well supported to stand alone.
- Please remove any other hooks or wire, as they can damage other artists' work.

*The form supplied with the advice of acceptance, must be completed and attached to the back of the work.*

- If selected, artists agree not to withdraw exhibited work before the close of the exhibition.
- Works must be submitted dry.
- Velcro dots and pins are not permitted.
- No work will be accepted if these requirements are not met.
- The committee reserves the right to reject wet, dangerous or fragile works that cannot be safely exhibited.

## HOW TO ENTER

Entries must be submitted as CD digital images of good quality or via EMAIL:  
**admin@civichall.com.au**

The artworks must include:

- the artist's name
- title of work
- medium used
- size in cm

The above information must be under the artwork displayed on the CD or EMAIL so that the curator can see those details when the CD/EMAIL is opened on the computer.

### ENTRIES TO BE ACCOMPANIED BY

- A signed entry form, with non refundable entry fee of \$22.00 (inc gst) for each entry.
- Artists may submit a number of images on the one CD, but an entry form and entry fee for each image must be supplied.
- Each artist whose work is selected will be notified together with date for delivery to the Gallery.
